DUTIES: Monitors operations of assigned area. Ensures that management directives are complied with. Ensures work schedules are accomplished and posted as required. Gets work started and set work pace. Relay supervisors instructions to assigned staff. Provides day-to-day guidance and training as needed. Ensures all necessary products/supplies are available timely and that employees follows, policies, directives, rules and safety and security, sanitation and housekeeping established standards. Ensures patrons satisfaction by resolving complaints and customers problems, elevating more intricate situations to supervisor in a timely manner. Inspects and secure facility as required. Upholds highest AF standards and meet requirements. Prepares a limited variety of hot beverages such as cappuccinos, brewed coffee, lattes, espresso, hot chocolate etc by selecting proper ingredients. Serves cold beverages and food items such as soda, juice, cookies, muffins, pastries etc. Maintains work area neat and clean. Set up/cleans tables for customers and replenishes condiment items as necessary. Sets up and operates dishwasher, performs preventive maintenance and cleaning . Scrapes , soaks, scours glassware, dishes and utensils as required. Also performs heavy duty cleaning tasks as required such as: coffee machines, ceilings, under and behind equipment , refrigerators, washes floors and walls, sanitize garbage cans. May unload stock from delivery trucks. Collects and transfers trash from work area to disposal area. Assist with inventories, identifies items for re-ordering. Performs other related duties as assigned.

QUALIFICATIONS:
Ability to lead three or more workers to accomplish food service duties. Must be able to follow oral instructions and use hand tools for cleaning and to operate simple machines. Must be skilled in doing tasks with several steps and use judgement in sequencing tasks. Knowledge of sanitation standards in handling and serving food, beverages and cleaning equipment and work area. Ability to communicate both orally and writing. Skill in dealing with public. Must be Physically able to frequently lift or move objects weighing up to 40 pounds. Must be able to continuously stand and walk, and frequently stoop reach, push, pull and bend for long periods of time. Must be able to obtain a Food Handlers certificate and /or complete Food Handlers training . Employment physicals required. Satisfactory completion of a National Agency Check required.
